Vijayakumari, Muthirakkal House., W/o Balakrishnan P Vemballur P O, Kodungallur 680671* and recommended to Renew Certificate of Approval (No Objection Certificate) No. **F-7474/18 dt 10/12/2018** of The Regional Fire Officer, Regional Fire Office, Fire and Rescue Services, Palakad for occupation of the said building as per inspection Report No. C-447/2022 Dated 29/08/2022 of the Station Officer, Fire and Rescue Station Kodungallur for **one year**.

2. In circumstances, this Fire Safety Certificate is issued under my seal and authority for the continued occupation of the above building. No further construction will be allowed in the vacant spaces provided in the approved plan.

3. This Certificate is issued on the condition that the fire fighting systems installed will be kept always functional and the owner of the building should take special care to maintain the systems installed in proper working condition. **This certificate is valid for one year from the date of issue. After one year the certificate must be renewed. Non renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by local self government/ Revenue Department.** All officers of and above the rank of Station Officers of the Fire and Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that the installed systems are good working condition.
