1.The Board headed by the Station Officer,Fire and Rescue station,KODUNGALLOOR has inspected the above said building and recommended to renew the No objection Certificate.

2. In the circumstances, this No Objection Certificate is issued under my authority for the continued occupation of the above building. No further construction will be allowed in the vacant spaces provided in the approved plan.

3. This certificate is issued on the condition that the fire fighting system installed will be kept always functional and the owner of the building should take special care to maintain the systems installed in proper working condition. **This certificate is valid for one year from the date of issue. After one year the certificate must be renewed. Non renewal of the certificate within the time limit will result in the loss of eligibility for insurance coverage and appropriate legal action by the Local Self Government/Revenue Department.** All Officers of and above the rank of Station Officers of the Fire & Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that the installed systems are in good working condition.

The above site Was inspected by the competent and authorized Officials of the Department. It was found that the site is suitable for the intended purpose from the fire point of view.
